 a) The EasyKauf Contract shall be reported to the Consumer Credit Information Office [IKO] pursuant to the statutory requirements. The applicant/buyer hereby authorises the seller to report the EasyKauf Contract to the Central Office for Credit Information [ZEK]. In particular, the type, amount and terms of the credit, the personal data of the applicant/buyer and any applicable payment defaults or improper use shall be reported. The Central Office for Credit Information is expressly permitted to make available this information to other members of the Central Office for Credit Information.  
 b) In connection with the EasyKauf application, the applicant/buyer has authorised the seller to collect any information that is necessary from third parties, particularly from the Central Office for Credit Information, authorities (e.g. debt enforcement and tax authorities, residents' registration office, guardianship authorities), credit agencies, intermediaries, employers and other suitable information centres, for a check of the provided information, a credit assessment as well as for the processing and handling of the EasyKauf Contract, which is hereby confirmed. The information to be collected may particularly include personal details, ability to pay and details on other liabilities of the applicant/buyer.  
 c) The applicant/buyer hereby agrees to the seller passing on the information obtained by it to a third party, either in Switzerland or abroad, for the purpose of checking the conclusion, maintenance and processing of the EasyKauf Contract, provided that the third party is obliged to maintain secrecy. The applicant/buyer is aware that his details may be transferred abroad and via the internet. The applicant/buyer consents to such data being transmitted and processed both in Switzerland and abroad.
